Sentencing Statement

It is, therefore, on 09/06/2024 **ORDERED and ADJUDGED** that the defendant is sentenced as follows:

Count 2: Defendant is sentenced to a term of eight (8) years in the custody of the Commissioner of the Department of Corrections, to run concurrent to Count 11.

Count 11: Defendant is sentenced to a term of five (5) years in the custody of the Commissioner of the Department of Corrections, with a minimum parole ineligibility of forty-two (42) months, to run concurrent to Count 2.

It is the intention of this Court that the Defendant serve an aggregate term of eight (8) years in the custody of the Commissioner of the Department of Corrections, with a minimum parole ineligibility of forty-two (42) months.

DNA Testing is required.

Counts 1, 3, 4, 5, 6, 7, 8, 9, 10 and 901 (W-2023-000264-1303) are dismissed.

It is further ORDERED that the sheriff deliver the defendant to the appropriate correctional authority.
