

picked it up, referring to the U-Haul. The attached AZ number plate and rental agreement were seized as evidence, bagged, logged, and placed in the SP Medford Temporary Evidence Locker. BROWN was given a copy of the rental agreement.

7. After returning to SP Medford, I contacted the listed U-Haul number on the rental agreement and spoke with an employee named Shane, who informed me that (AZ AG64565) was not listed in their internal tracking system. I further spoke with U-Haul representative named Iesha from U-Haul Equipment Recovery, who also advised that the aforementioned registration number did not appear in their internal tracking system. Further investigation regarding the attached number plate will be conducted and an additional report will be submitted. This report is merely a summary of the events. SUMMONS

1. On Saturday July 2, 2022, AHQ Dispatch relayed a BOLO regarding a U-Haul truck, that loaded shields and helmets from a group of individuals at intersection of Dartmouth and Stewart Street in the City of Boston. Additionally, the MSP Airwing was actively monitoring and relaying the U-Haul trucks location as it traveled north on Route 93 from Boston to Stoneham.
2. At approximately 14:12hrs, Sgt Tulipano observed the aforementioned U-Haul truck, bearing Arizona registration AG64565 traveling north on Rt93 in the vicinity of Montvale Ave in the Town of Stoneham. A check of the registration number by AHQ Dispatch, revealed that it was expired as of 6/30/22. The query further indicated that the expired plate was not associated with a vehicle. Additionally, the name and customer number sections were blank. MV stop conducted just prior to Rt95 in Stoneham.
3. The operator of the U-Haul was identified by his Washington State Driver's License as BROWN, Colton m., DOB: 10/12/98. BROWN further supplied the U-Haul rental agreement, which indicted the vehicle had been rented to him on July 2, 2022, at 8:08AM from the U-Haul location located at 286 Daniel Webster Highway in Nashua, NH. I further observed the registration number listed on the rental agreement did not match the registration plate attached to the U-Haul. The rental agreement listed the vehicles registration number as Arizona AE26859. A check of this registration number showed that it was for a 2011 Ford Econoline truck, VIN #1FDXE4FS1BDB20798. I visually confirmed via AHQ Dispatch that the VIN on the vehicle matched the VIN listed on the CJIS query.
4. Arizona number plate AG64565 was attached to the rear of the U-Haul with two weathered license plate style screws and one metal type screw that appeared to be new. The apparent metal screw was drilled directly into the metal frame of the U-Haul trucks cargo bed. I further observed approximately five non-factory screw holes in various locations on the number plate, indicating this plate has been repeatedly attached/reattached in the past.
5. BROWN claimed no knowledge of why the attached number plate didn't match the registration number listed on the rental agreement. Criminal Citation T23583411 was issued in hand to BROWN, which he signed, for Attaching Motor Vehicle Plate Unlawfully to Conceal Identification of Motor Vehicle. A complaint for a Summons for this offense will be taken out on him at Woburn DC. The other two occupants were identified by their PA and IL Driver's Licenses as RAY, Keith Mathew DOB: 5/30/94 and GARLAND, Garret J. DOB: 10/26/98.
6. Trooper Surian conducted an inventory of the U-Haul prior to it being towed. Approximately 25 metal/Plexiglas riot type shields and approximately 40 American Flags attached to poles along with a drum and a megaphone were some of the items observed. The U-Haul was towed by Stephens Towing to their yard located at 60 Union Street in Medford. Trooper Resmini transported BROWN to Stephens Towing, where I spoke further with him to obtain his booking information for the Summons. BROWN confirmed that his address in Washington State was valid. The rental agreement listed his address as 2 Vista Lane in Spencer MA, 01562 and his telephone number as (774) 487-8876. I asked BROWN about the Spencer MA address. BROWN informed me that it was on the rental agreement because Brian Harwood who lives at the address had ordered it, BROWN clarified that he had only
