## FEDERAL BUREAU OF INVESTIGATION

On April 12, 2008, a surveillance operation was conducted by members of the Federal Bureau of Investigation (FBI), Detroit Division, Lansing Resident Agency. Also participating in the operation were members of the Michigan State Police (MSP), Lansing Police Department (LPD), and Michigan State University Police Department (MSUPD).

[REDACTED] This meeting, [REDACTED] by [REDACTED] was advertised as a forum for facilitating a unification of these groups. The forum was to promote a direct course of action rather than to merely talk about issues or problems.

Between 4:15pm and 4:25pm, the above mentioned vehicles and individuals began to leave the area of the CC. Some of them were loosely followed by surveillance team members, and none of them were tracked to Coscarelli's.

Although surveillance team members who were covertly positioned in Coscarelli's observed employees preparing a private dining area of the restaurant, no one arrived for a meeting.

Marriott East Lansing University Place, 300 Mac Avenue, East  
Lansing, Michigan.

At approximately 4:55pm, Kyle Bristow and 2 unidentified white males were observed walking into the Marriott East Lansing University Place. Within minutes, Bristow and the 2 men left the hotel, and surveillance team members were unable to observe their direction of travel.

Members of the surveillance team attempted to locate Bristow at the Bluegill Grill on Lake Lansing Road in Haslett, Michigan. Bristow had been reported to have held meetings or frequented the Bluegill Grill in the past. A check of the

restaurant produced negative results for Bristow or any of the meeting attendees.

Believing the meeting had been cancelled or moved to an unidentified location, the surveillance was terminated at approximately 6:15pm.

After leaving the surveillance, TFO [ ] checked an additional location and located the meeting. At 7:15pm, vehicles initially identified at the CC were observed in the parking lot of the Courtyard By Marriott, 2710 Lake Lansing Road, Lansing, Michigan. TFO [ ] observed numerous individuals exiting the hotel and walking back to their vehicles. Their departure as a group indicated the meeting had concluded. TFO [ ] identified an individual walking to a vehicle as [ ]. Due to his position in the parking lot, TFO [ ] was unable to photograph or follow any of the individuals leaving the meeting. TFO [ ] documented the following vehicle registration plates potentially related with meeting attendees:

At approximately 7:40pm, when it appeared the meeting had concluded and the attendees had left the area, SA [ ] TFO [ ] and TFO [ ] entered the lobby/lounge area of the hotel. Next to the lobby/lounge area was a small unoccupied conference room. SA [ ] entered the room, which was accessible to the public through two unlocked doors. The positioning of tables, chairs, and a podium were indicative of a speech presentation format. In the room's sole trash container, on top of the discarded refuse, there was four pieces of 8 1/2"x11" paper folded together. Printed on the paper were speech notes in outline format for Bristow's presentation. The notes contain the following content:

"Thank [ ] for organizing event. Thank [ ] for making the trip. Thank audience for being here.

- B. Quotes from my articles:
  1. "If you ask me, the whole of the Third World is not worth the blood of a single American soldier."
  2. "Traitors to Western civilization feel that Westerners should apologize to the world for things such as slavery, causing so-called global warming, denying women the right to vote, establishing colonies, fighting the Crusades, not allowing for homosexual "marriage," and whatnot. I have nothing to apologize for. While my civilization produced Bachs and Mozarts, Einsteins, and Pasteurs, Aristotles and Platos, the people of other cultures were sacrificing captives to the "sun god," shoving bones through their noses, and running through the forests in loincloths with the intent of scalping one another."
  3. "If Western civilization and our country are to be preserved for future generations, the ideology of globalism must be confronted by the patriots of our nation. The globalists who wish to deny our people of our culture and our sovereignty and our legacy must be stopped. Enough is enough. It is time the patriots rise, stand up as one, and cry out in one united voice, "Here marches the national resistance!"

Tactic of name branding:

In Patrick Buchanan's Death of the West, he quotes what one supporter of the Frankfurt School said of Critical Theory, the weapon that the Marxists devised to subvert Western culture: "[Critical Theory is] essentially destructive criticism of all the main elements of Western culture, including Christianity, capitalism, authority, the family, patriarchy, hierarchy, morality, tradition, sexual restraint, loyalty, patriotism, nationalism, heredity, ethnocentrism, convention, and conservatism."

We need our own Critical Theory. We must be as ruthless as the leftists. I would define our critical theory as essentially destructive criticism of all the main elements of liberalism, including moral and cultural relativism, socialism, anarchy, deviancy, disloyalty to the nation, racial diversity, multiculturalism, and internationalism.

Repetition impresses the subconscious, and in time, we will win.

The leftists are ruthless; they act without mercy. Tried to get this meeting banned. Tried to get MCRI meeting at grocery store stopped. They spy on us. Be sure to thank the manager of the restaurant on your way out for letting us use their room.

#### Experiences with YAF
